Voting on Acceptance of ExCB *Unit Kiwa ExVision of Kiwa Nederland B.V.* (KIWA) to issue IECEx Conformity Mark Licenses

Introductory Note

This document provides a report to ExMC Members concerning the application from *Unit Kiwa ExVision of Kiwa Nederland B.V.* (KIWA) of NL to be accepted by ExMC as an IECEx Conformity Mark License issuing ExCB.

This report was circulated to ExMarkCo members for comment and as there were no objections by the closing date for comments it is now provided for ExMC Member consideration.

Background

The IECEx Secretariat had received an application from *Unit Kiwa ExVision of Kiwa Nederland B.V.* (KIWA) of NL to become an IECEx Conformity Mark License issuing ExCB

This application was received by the IECEx Secretariat in accordance with IECEx 04 and OD 422.

In accordance with IECEx OD 422 Clauses 1.6 and 2.4, the Secretariat conducted a detailed review of the "ExCB" documentation supplied. This documentation along with updated documents arising from the Secretariat's Document review stage, was circulated to the IECEx Conformity Mark Committee, ExMarkCo for consideration by correspondence.

The consideration of the KIWA application was successfully completed by ExMarkCo with ExMarkCo now in a position to recommend acceptance by ExMC, of KIWA as an IECEx Conformity Mark License issuing ExCB.

In proposing ExMC acceptance, ExMarkCo include this report as a summary of the main items successfully reviewed by ExMarkCo, concerning the KIWA application.

Action required of the ExMC

The ExMC are asked to approve the ExMarkCo recommendation of Acceptance of ExCB KIWA to issue IECEx Conformity Mark Licenses.

Observations and Findings

A full review of the KIWA documentation (refer Annex A for list) according to the IECEx Requirements of Clauses 1.1 and 2.4 of OD 422 was carried out as follows:

| | KIWA has provided copies of their procedure to issue an IECEx Conformity Mark. This procedure was reviewed as part of the ExMarkCo assessment process and found to comply with IECEx requirements including all steps and stages detailed in Table 2 of OD 422. This includes incorporation of the IECEx Standard Terms and Conditions, OD 023 into the KIWA requirements that will be placed on holders of an IECEx Conformity Mark License. |

ExCB Activity History

KIWA, since being accepted as an ExCB in the IECEx Scheme, has issued a total of twenty nine (29) IECEx Certificates and associated reports.

Recommendation

The IECEx ExMarkCo recommends that this application from KIWA to become an IECEx Conformity Mark License issuing ExCB be accepted by the ExMC.
